

Get Ready with Jr. Guard Prep & Conditioning

Jr. Guard Prep is a swim class designed to re-fine and improve the skills needed to pass the requirements for Jr. Guards testing and recondition those returning to the JR Guard program. Skills taught will include stroke technique, stroke efficiency, rotary breathing, sculling (for treading), breath control, pacing and underwater swimming. Students will also prep for the test by rehearsing in class!

Please note: This is not a swim<u>lesson</u>. All participants must already know how to swim freestyle for a min of 50 yards (two lengths).

Classes meet once per week on your selected day (Tue,Thurs or Sat) for 4 consecutive weeks. No make-ups or pro-rated fees.
